Chinese Christians and Social Involvement

In April 2012, a church in Wuhan initiated a movement for Christians to donate blood. Since then, they have set November 25th as the annual "Christians Voluntary Blood Donation Day", and the day has been tacitly approved by the government as it has been on-going for the last few years (picture bottom left).

On June 1st, 2013, members of a church in Chengdu went on the streets to pass out leaflets that said "No abortions on Children's day". However, they were stopped by the authorities (picture bottom right).

These two events might seem to be unrelated, but they demonstrate that Chinese Christians are trying to be more involved in social projects – sometimes successful, sometimes not. It is a reality that the Chinese church is beginning to play a part in addressing more social and community needs.

Chinese society at large is familiar with Christians doing charitable work. Ever since the arrival of Christianity in China, foreign missionaries and local believers have been involved in charitable work. They have played an





important role in education and health care, they ran orphanages and drug rehabilitation centers, advocated for the abolition of foot-binding of women and helped refugees during various wars. All of this is still remembered by many. This writer has seen many examples of charitable works that continue to this day. For example, in a hospital in Lanzhou, a sign from a leprosarium in the early 20th century still declares that "God so loved the world" (picture bottom left). In a hospital in Zhejiang, an old publication declares that this hospital was started by Christians in 1912. (picture bottom right).

Christians have been reluctant to get involved in social or charitable work. Since the 1990s, as Christianity has spread more widely, especially in the urban centers, Chinese Christians are once again considering what it means to be a Christian in society. This was especially true after the Sichuan earthquake in 2008. According to reports by the government, there were 1,060,000 volunteers who helped in the disaster zone, of which 60% were Christians. This shows that the main volunteer force in China is composed

However, in the West during the early 20th century, there was a controversy concerning the so-called "social gospel". Many Chinese Christians chose a different path - they began to mainly emphasize evangelism and personal spiritual growth. "Fundamentalism" was a key characteristic in the development of Chinese Christianity at that time.

During the period 1950 – 1979, Chinese society went through a tremendous upheaval. Since then, due to the influence of fundamentalism and unprecedented social changes, many

of Christians. Although the Christian volunteers from house churches were not organized by anyone, they were willing to step out in faith and reach out to those in need. This was a great example of what can happen, even in today's materialistic society. Since

Proyer Points November 2017

According to church tradition,
November is the month for a special
time of thanksgiving to God. Let us
give thanks to God for watching over
the Chinese church, and especially for
the fact that Chinese believers are now
seriously considering how to be involved
in social projects as an expression of
God's love.

Please pray for Chinese Christians working with AIDS patients, especially those looking after the children of those affected by the disease.

Remember the spouses and children of those serving prison sentences. Pray especially that teenage children can be helped and nurtured by mature Christian adults.

4 There is a local ministry whose focus is the children of prisoners. Through seminars and other methods, they are making local churches aware of the needs of these children. May more churches gladly and wholeheartedly step up to join in this ministry.

5 Pray for workers in large factories like Foxconn Technology Group. There are usually over 10,000 workers in each factory, mostly in their twenties. Pray for those sharing the gospel with them.

6 Pray for those leading Bible studies in the dorms for factory workers; they

are workers themselves, and faces many pressures. May the Lord strengthen them and enable them to have a good and effective witness.

Pray for those working with left-behind children in rural areas. Some urban churches are starting to do regular visits. We give thanks that these ministries are developing; may the Lord raise up more to participate in this ministry.

Pray for a farmer in central China who has adopted ten disabled children. His family support these children in addition to running a farm. May the Lord strengthen and encourage them in the midst of all the demands of daily life.

Please pray for those who have continued to serve in Sichuan, following up after the 2008 earthquake. Their ministries have changed from disaster relief to agricultural development and children's education. May the Lord grant them wisdom, courage and resources going forward.

10 Please pray for those who adopt abandoned babies. Due to government policies, they have to pay more and deal with a lot of "red tape". If they are unwilling to pay a bribe for the necessary documents, they can hit roadblocks in the process.

11 Government policy only allows parents without children to adopt, so most Christian families are unable to adopt children. May the Lord open doors for needy children to be adopted by Christian families.

12 An abandoned baby boy named "Hosea" has finally been officially adopted by a Christian couple, after a difficult two year process. Pray for this child and his adoptive parents, that he will grow up knowing that the Lord has a wonderful plan for his life.

13 Pray for local ministries that are trying to minister to abandoned babies. Even when Christians manage to register an organization to take care of them, everything is very difficult because of the excessive red tape, lack of a basic framework and limited professional help.

14 China has now moved on from the "one-child policy" to a "two-child policy" But there is still a national reproductive policy in place. Some Christian families have more than two children. Please pray for two college professors who face the possibility of being fired because they each have three children. May the Lord guide and provide for them.

15 Thank God for a church in Guangxi that has been taking care of minority students for over ten years. Some of these students have now graduated from high school and are starting at university. Some others are getting theological training in order to serve God in minority areas. Pray for them, that as they enter this new phase of their lives, they will depend on the Lord and continue to live for His glory.

16 Please pray for drug rehabilitation ministries run by Christians. In Guangdong and Yunnan provinces, Christian doctors have set up these types of ministries. However, due to the

sensitive nature of this work, the lack of funds and limited professional help, they face great challenges. May the Lord encourage them by bringing willing, skillful people to join them in this ministry.

17 Some nursing homes have successfully registered in China, but they are all in rural areas, where there is a lack of professionals to do the work. May the Lord lead more urban churches to get involved in this important ministry.

18 Traditionally, Chinese have always honored the elderly among them. There is therefore great difficulty in setting up nursing homes in urban centers. Please pray for local churches, that they will show honor to the elderly by caring for them in practical ways.

19 Chinese rural churches lack pastors and their congregations are aging. Some of the elderly cannot be taken care of by their children (because they have gone to work in the city). May the Lord send urban Christians to visit the elderly in the rural areas on a regular basis, to provide them with emotional support, health care and other services.

20 Chinese Christians who want to help with social needs have few legal opportunities to do so. This can be very discouraging and demotivating. May the Lord help them to overcome the obstacles to service and be witnesses for Christ as they demonstrate His love in their communities.

21 In Wuhan, one house church was able to register a food bank and they run it in partnership with a

government agency. May the Lord continue to bless this church, that they can meet the physical and spiritual needs of many through their food bank.

22 "Christian's voluntary blood donation" day. Please pray for the preparation of this event in cities across China, so that more Christians can participate and demonstrate God's love in their communities.

23 Today is Thanksgiving Day in the USA. Many Chinese churches hold similar thanksgiving gatherings at this time. May the Lord bless both organizers and participants, so that they will more deeply appreciate the love and goodness of God.

24 In some cities, churches are spending a lot of time and money negotiating with various government departments to prepare a suitable venue for November 25th's "Christian's voluntary blood donation" day. Pray for favor in the eyes of government departments.

25 Today is China's "Christian's voluntary blood donation" day. May the Lord protect and use Christians who are participating in this event, so that more in the community can understand that Christians serve a God who is full of goodness and mercy.

26 Please pray for the Chinese church as they look for ways to be involved in society, to be witnesses for the Lord, and to share His love in their communities. May the Lord be at work to expand these ministries, so that

many lives will be touched by the love of Christ.

27 We thank God that some Chinese Christians have been able to get involved in charitable work. However, there are many barriers to involvement in health care, education and work among minority groups. Christians are also forbidden from getting involved in ministries that involve social justice or care of AIDS sufferers. May the Lord continue to open new doors for Christian social engagement.

28 The Chinese church needs to better understand the value of doing charitable work in society. May God open their eyes to opportunities for demonstrating the gospel in deed as well as sharing the gospel in word. Pray that Chinese Christians will persevere in this direction over the long term.

29 Please pray for NGOs being registered by Chinese Christians. Due to the fact that NGOs can only be registered by individuals and not by churches, there is a lot of pressure associated with the registration process, causing many difficulties. May the Lord continue to sustain those NGOs that are operating well now.

30 We know of Christians who have started a "Christian NGO incubation" ministry. They can give assistance to those who want to register as NGOs and mobilize people for service in China. But they face a lot of political pressure. May the Lord strengthen, sustain and guide them – and grant them success!

then, there has also been a growth in the number of drug rehabilitation centers run by Christians, and ministries to prisoners have developed. Christians have also reached out to left-behind children, assisted orphans, and started nursing homes for the elderly.

There are five big issues that face Chinese Christians as they seek to become involved in charitable and social work:

1. The church has no legal standing as it tries to be involved in charitable enterprises.

For historical reasons, the majority of Chinese Christians attend unregistered house churches. These churches are not recognized by society or the government. So it is hard for Christians to do any sort of charitable work in Chinese society under the name of a church.

2. The government wants to start charitable enterprises but is unclear how exactly it wants to do it.

On September 26th 2013, the General Office of the State Council circulated a paper "Regarding government social services guidelines". This sets out requirements for the safe and orderly implementation of social services, under the principle of gradual reform and innovation. By the year 2020, the whole nation is supposed to have developed a basic framework for government spending on charitable services to match its economic developments. They

want public funds to be used effectively and only spent on "proper" enterprises. But churches providing these charitable services are not recognized by the government as "proper" enterprises. As things are at present, Christians can only serve social needs as individuals; this makes it hard to deal with the government who wants to work with organizations.

3. Christians want to serve, but face many difficulties.

A few Christians have managed to register charities, such as community centers or nursing homes. In theory, government officials want to be able to work effectively with charitable enterprises. But there are very few churches or Christian organizations that can openly bid for social service contracts. Usually government departments set up a certain number of social services for a certain period of time. For example, with the ageing of Chinese society, the government has been pushing for nursing homes to be built. But traditionally Chinese people have an aversion to placing their parents in nursing homes. As a result, it is hard to find physical building spaces in urban areas in which new nursing homes might be built. The government has allowed Christians to open nursing homes in the outskirts of cities, thus solving one of the most pressing issues in China today. But they do not want those Christians to influence the community, and there are strict restrictions on evangelization.

4. The new laws are hard to understand and implement.

In September 2016, China began to implement "Charitable Laws". Quoting, "in order to establish charitable organizations, application for registration should be made to the civil affairs department of the people's government at or above the county level. The civil affairs department shall make a decision within 30 days of receiving the application. Those who meet the conditions prescribed in this Law shall be allowed to register and have a public profile. If they do not meet the conditions prescribed in this Law, they shall not be registered and the reasons shall be stated in writing."

In practice, not only do charitable organizations need to register with the proper government department, they also need to have a "competent business unit" to issue a certificate that is used for registration – this is causing a lot of problems. According to the Xinhua News Agency (September 1st, 2016): "There are currently 600,000 social organizations that have registered, but there are millions of others that are not yet registered. Due to the difficulty of registration, many charities are currently operating illegally. So in effect, when the "Charitable Laws" are implemented, the government will be working with charities that are actually operating illegally. According to the new "Religious Affair Regulations", house church charities have no right to operate, and no right to provide social services that the government might fund. Christians as individuals can volunteer and help, but technically churches cannot run any charitable organizations.

5. Although overseas NGOs continue to operate, there are many limitations on them.

After the implementation of the "Charitable Laws" last September, the "Foreign Non-Governmental Organizations" Law also went into effect. According to reports, there are over 7,000 overseas NGOs in China. mostly doing poverty alleviation, medical work and community development work in rural areas. The new law does not affect how these overseas NGOs operate on a day-today basis. Instead, it seeks to regulate how foreign funds can be used in China. Overseas NGOs are required to find the relevant business department to register with, so they can then take that registration and apply for legal status with the Public Security Bureau. In addition, without government permission, these overseas NGOs cannot partner with any local organization. So this effectively blocks the church from working with an overseas NGO.

Even as difficulties abound, the 21st century Chinese church is still trying to work out how to apply the principles taught in the story of the Good Samaritan. One pastor quotes Rev. Martin Luther King, "A great country must be a loving country; a person who does not care about the vulnerable cannot be a great man, and a country that does not care about the poor cannot be a great country."

One very good thing is that Chinese Christians are no longer asking "Why do we need to be involved in society?" but are now asking "How should we serve our society?" Some urban church leaders are saying: "Because we are chosen by God, we must follow the Great Commandment. We must serve those around us and preach the Good News to those who have not heard, so that they too can experience the love of Christ.

May God continue to lead the Chinese church as it grows in maturity and seeks to serve society in the spirit of Christ!
